#### 2. Governance, Roles and Responsibilities

Oversight of modern slavery compliance sits with our senior leadership team, supported by HR and our compliance function.

Modern slavery risks are reviewed annually as part of our wider risk-management and ISO 27001 ISMS governance cycle, ensuring alignment with relevant controls, including:

- A.7.4 / A.7.5 – Employee screening and employment terms
- A.5.19 / A.5.20 – Supplier relationships and due diligence
- A.6.3 – Ethical considerations in project and operational management

This ensures modern slavery considerations are embedded into our organisational processes.

- Maintaining fair recruitment and people-management practices

## 4. Our Supply Chain

Our supply chain consists primarily of large, global software development companies and communication-hardware providers. These organisations typically operate within regulated environments, maintain formal ESG and labour-rights commitments, and are subject to shareholder and statutory reporting obligations.

### We assess our overall supply-chain risk as low due to:

- The high-tech, low-labour-intensity nature of the products and services we procure
- The maturity and transparency of our suppliers
- The presence of published Modern Slavery Statements and international labour-rights commitments among key partners

## 5. Supply-Chain Due Diligence

While we do not have direct access to the internal workforces of large multinational suppliers, we support workers' rights and ethical labour practices by:

- Conducting supplier due-diligence checks, including reviewing modern-slavery statements and ESG disclosures
- Including ethical-labour expectations in procurement and contract reviews
- Prioritising suppliers that demonstrate compliance with internationally recognised labour standards
- Monitoring publicly available information on supplier governance and workforce practices
- Integrating modern-slavery considerations into our ISO 27001 supplier-risk assessments

## 6. Policies Supporting Modern Slavery Prevention

The following policies support our commitment and are available to all staff through our Employee Handbook:

- Improve documentation and audit trails within our ISMS
